Roll call: Rachel and Rodolfo absent

Chair announcements: Next meeting is the last of the semester. We will decide our meeting schedule for the next semester. Also we will create a standard way of deciding how to present changes to the Golden Rule. Please try to meet with your contacts to finish updates before the next meeting.

Jorge: On page 13 of 5.006 in section F1, it should be clarified that both parties shall be notified of the available assistance. This should be carried down through F8.

Gilmer: Language about irrelevant behavior can be tightened up. This isn't university regulation so we have flexibility to change this language.

Princelee: On page 34 of 5.009 in section 1a should be changed to "will assign the case" and second period should be eliminated. On page 37 in section 4a2 fix punctuation. On page 69 in the second to last line of section 1c delete the extra space. Will bring typed up changes to be voted on.

Lauren: On page 45 of 5.11, the PDF uses letters and print copy uses numbers.

Jacob: Still need to define active or inactive, looking to change to be more appropriate because inactive members aren't part of organization and can't be held to the same standard. Can be held responsible, is worded differently in other places. Alumni is also used and that may not be appropriate. Also guests may need to be changed to invitees because organizations can't be held responsible for random people who showed up whom they escort out. A good faith effort by the organizations to prevent problems should be taken account.

Gilmer: You should refer back to university risk management policy

Lauren: Regarding medical amnesty, Betz said we need to do more research and for legality and liability reasons we need to get it approved and make sure we're clear that the student will not get in trouble for calling the police. The main concern is student safety even though parents may not like it. UF and FSU have it.

Princelee: An additional issue is whether you're liable if you're present while someone is doing it.

Jacob: Needs to be clear that we are not speaking for the police but speaking for the school.

Lauren: Students won't be held for student conduct through school, but police may press charges.

Gilmer: It is called amnesty from disciplinary action (University of Tampa). Make it say from the University of Central Florida just to be extra clear. Students could still have educational action but no punitive action.

Jacob: Need to add that there is educational action. (Example: Meet with counselor.)

Sara: Do parents need to be notified of educational sanctions?

Gilmer: Under FERPA if the student is under 21, parents are notified after first medical transport or 2nd alcohol.

Gilmer: Could restructure 5.013 and explain that 6a-e are punitive and add a 7 outlining the most popular educational sanctions.

Gilmer: Marketing ideas are videos to be pushed at the beginning of the year. Have residence life, OSI and FSL use it, and make sure that it can last 5 years without being too outdated.

Jorge: Volunteer UCF and civic engagement advisor could help with video.

Change to Golden rule:

5.007 (page 23, section 3): Change "Student shall not be forced" to "Students" Voting 6-0-0.

Change accepted.
