- **Overview of the purpose of the Committee**
  - Timeline for Review - The GRRC reviewed the timeline for moving forward with updates to the Golden Rule to have everything ready for Fall 2019. The GRRC plans to have all updates ready by April 2019.

- **Old Business**
  - **Academic Grade Appeal Process (Julian)**
    - Online student grade appeal policy/satellite students – language currently being reviewed
    - Look into Graduate Studies appeal process
    - Met with dean of Undergraduate Studies
    - Schedule meeting with OIE to discuss language pertaining to grade appeals involving discrimination
  - **Interim Suspension Process (individual/organizational) (Kyler and Kat)**
    - Ask Kyler for updates on panel review process
    - Look into adding more student voices to the process by putting SDES/SGA leaders onto the panel
  - **Hazing Amnesty (punitive) for Organizations (Kyler)**
    - Looked at written proposal submitted by Kyler.
    - Consider revising proposal so the language is less Greek specific and more gender inclusive
  - **Judicial Branch Student Conduct Hearing Board (Jad and Kat)**
    - Florida case law: anything involving SGA is open to public record, might run into conflicts with FERPA.
    - Alternative idea: student-led CREED program
    - Idea to create a student-led case management team to assist with following up with individuals and the completion of their sanctions
  - **Inclusivity and Cultural Competence Project (Samantha)**

- Contacted Multicultural Student Center and Office of Diversity and Inclusion, no response
    - Reach out to Office of Social Justice and Advocacy next
  - **Downtown Campus Language (Dorel)**
    - Emailed deans of both UCF and Valencia
    - Will meet with Dr. Frame
  - **Title IX Review (Sabrina)**
    - Ran into problems adding Title IX resources to Golden Rule. Initiative might not materialize
    - Look into ways to add more transparency to the investigation process (such as providing continuous investigation updates)
- **New Business**
  - **Free speech zones**
    - Kat researched the issue of free speech on campuses. It will be difficult to regulate speech. Additionally, as the Golden Rule applies to the students, and UCF is a public university, not much can be done regarding non-students. Will look into these issues.
